City of Horseshoe Bay City Council Comments

November 14, 2023

The City of Horseshoe Bay City Council meeting was held on November 14, 2023, at 3 p.m. in the Council Chambers. Mayor Thurman called the meeting to order and welcomed those in attendance. The invocation was given by Pastor Malcolm McQueen with The Church at Horseshoe Bay, followed by pledges to the American flag and the State of Texas flag.

Announcements and Staff Recognition

Legislative Services Director Kerri Craig swore in newly appointed Council Member Larry Morgan and newly elected Mayor Elsie Thurman.

Utilities Director Rick Williams introduced a new employee, Logan Stump, a utility plant operator, who was absent due to training.

Fire Chief Doug Fowler introduced Kyle Schmidt, promoted to Captain, who was absent due to training.

Sally McFeron, Director of Development Services, presented Utilities Supervisor Ray Garcia with his five-year service award.

Public Works Director Tim Foran presented Public Works Assistant Director Cody Layton with his 15-year service award.

Utilities Director Rick Williams presented Elizabeth Palos and Samantha Sosa with their five-year service awards.

Seven residents spoke of their willingness to serve on committees from the Board of Adjustment, Planning and Zoning, and Transportation Advisory Committees. The Mayor asked the Council to thank them for their willingness to serve the City. The Mayor explained that the Council would decide on appointments to each committee at the December 2023 Council Meeting.

Business

A. Mayor Elsie Thurman elected Elaine Waddill to the position of Mayor Pro Tem. The council voted, and the motion passed unanimously.

B. Annual Appointment of Two Council Members to the Public Funds for Public Purposes City Council Subcommittee. The mayor recommended Dwight King and Larry Moran to serve on the subcommittee. The council voted, and the motion passed unanimously.

C. Ordinance 2024-02: Utilities Director Rick Williams asked that the ordinance be tabled until the December meeting to give the staff more time to update the ordinance based upon the City Attorney's recommendations.

D. Resolution 2024-03: Development Services Director Sally McFeron presented a request for removal from the City's extraterritorial jurisdiction (ETJ) by Gordon M Griffin III, President of CGG Holdings V, LLC. The requested acreage of land in HSB ETJ is 89.145 acres to be released.

Director of Development Services Sally McFeron pointed out that state law, S.B. 2038 (Bettencourt/C. Bell), provides the ability to pursue release from the city's extraterritorial jurisdiction (ETJ) by petition or election. The bill further provides for release by "operation of law" if the city does not release the area within 45 days or by the city council. The council voted, and the motion passed unanimously.


