We recently completed a project to make historical legal research more efficient. Old volumes of *Vernon's Texas Statutes and Codes Annotated* and the corresponding pocket parts were moved to a publicly accessible area of the library mezzanine.

These key resources are now housed in one location, making it easier to trace the development of Texas law. This has also freed up shelf space for heavily used volumes like *Texas Jurisprudence* <<https://catalog.sll.texas.gov/cgi-bin/koha/opac-detail.pl?biblionumber=25367>>, case reporters <<https://guides.sll.texas.gov/historical-texas-cases>>, and session laws <<https://guides.sll.texas.gov/historical-texas-statutes/session-laws>>.
